#### **EXPLANATION OF COLUMN HEADINGS IN THIS DOCUMENT**

Note that full details regarding Kimberley DAMA occupations and concessions are contained in the Kimberley DAMA Information Guide available in the EKCCI website. The following is a summary only and business decisions should not be made without referring to the detail in that Information Guide.

OCCUPATION: Occupations available under the (renamed) Kimberley DAMA as of 22 December 2023. Under the Kimberley DAMA, occupations have access to range of concessions not accessible in standard skilled migration programs, as well as well-defined permanent visa pathways. Many occupations in standard skilled migration pathways are subject to caveats that do not apply when accessed under the Kimberley DAMA. REFER ALSO ITEM 1.6 IN THE KIMBERLEY DAMA

ANZSCO CODE: Occupation codes as listed in the *Australian and New Zealand Stand ard Classification of Occupations* (ANZSCO). Note that occupations in this list with the code 070499 are non-ANZSCO occupations. For details of ANZSCO occupations, including position description, see the ANZSCO website (you can search by occupation name or ANZSCO code). The list also includes alternative titles and specialisations as listed in ANZSCO. For non-ANZSCO occupations, see the position descriptions in the EKCCI website. REFER ALSO ITEM 1.6 IN THE KIMBERLEY DAMA INFORMATION GUIDE.

**SKILL LEVEL**: Relevant skill level as listed in the *Australian and New Zealand Standard Classification of Occupations* (or as determined by *Department of Home Affairs* for non-ANZSCO occupations).

**BROAD OCCUPATION GROUP**: Note that an occupation may be relevant to more than one occupation group. If searching by occupation group, be aware that some occupations relevant to you may be in a different occupation group. Example: a Cook may be relevant to a business operating in the Child Care sector (Social Services occupation group), but will be listed in the Tourism and Hospitality occupation group.

**TSMIT / CSIT CONCESSION**: This column indicates whether a TSMIT / CSIT concession ('salary concession') is accessible for the occupation. For full details, REFER ITEM 1.10 IN KIMBERLEY DAMA INFORMATION GUIDE. TSMIT relates to the SESR 494 and CSIT relates to the SID 482 and the ens 186.

**ENGLISH LANGUAGE CONCESSION**: This column indicates whether an English language concession (as required at nomination/visa stage) is accessible for the occupation. FOR FULL DETAILS, REFER ITEM 1.11 IN KIMBERLEY DAMA INFORMATION GUIDE.

AGE CONCESSION: This column indicates whether an occupation has access to an age concession (the maximum age for the Overseas Worker) at time of lodging a nomination application for an ENS 186 (permanent) visa, or a SESR 494 (temporary) visa, under the Kimberley DAMA. Note that the Overseas Worker 'must not have turned' this age at date of nomination. REFER ITEM 1.14 IN KIMBERLEY DAMA INFORMATION GUIDE.

**PERMANENT VISA PATHWAY**: All occupations in the Kimberley DAMA Occupation and Concessions List may have access to a permanent visa pathway. The holder of a **SID** visa granted under a Kimberley DAMA labour agreement may be eligible for an **ENS** (permanent) visa after two years. Time spent in the Kimberley DAMA Designated Area working in the same occupation on a non-DAMA visa may also be counted towards ENS eligibility. Note that the ENS also requires separate endorsement. The holder of a **SESR** visa granted under a Kimberley DAMA labour agreement may be eligible for a **Permanent Residence (Skilled Regional)(191)** visa after three years (that does not require separate endorsement). REFER ITEM 1.1 AND 1.13 IN KIMBERLEY DAMA INFORMATION GUIDE.

SKILLS, QUALIFICATIONS, AND EXPERIENCE: This column indicates the skills, qualifications and experience requirements (as required at nomination/visa stage) that will be listed in a Kimberley DAMA Labour Agreement for the specific occupation/s. The requirements for each Category are listed in the Kimberley DAMA Information Guide in Item 1.12 (be sure to use the version issued on or after 6th of May 2025, as in the EKCCI website).

SKILLS ASSESSMENTS: This column indicates the relevant Skills Assessing Authority for the occupation. For occupations in Groups 1-2 refer to the Department of Home Affairs website via the link provided to determine the correct skills assessing authority, as the skills assessing authority may be different depending on visa pathway. Note that occupations in Categories 1-2 may not require a mandatory skills assessment for the SID 482 option, unless certain circumstances apply (see the legislative instrument at https://www.legislation.gov.au/Details/F2018L00294). Occupations in Categories 1-2 using the SESR 494 option require a mandatory skills assessment, as they do in the standard SESR 494 pathway. Occupations in Categories 3-7 also require a mandatory skills assessment. REFER ITEM 1.13 IN THE Kimberley DAMA INFORMATION GUIDE.

VISA OPTIONS: The Kimberley DAMA provides access to the SID (temporary) visa and to the ENS (permanent) visa pathway (both of which require separate endorsement), and to the SESR (temporary) visa (that may lead to the PESR permanent visa option outside the Kimberley DAMA that does not require endorsement). Employers must specify the visa option sought for each occupation/position when requesting endorsement. For multiple occupation/position requests, a combination may be requested. REFER ITEM 1.1 IN Kimberley DAMA INFORMATION GUIDE.

DESIGNATED AREA: The Kimberley DAMA Designated Area aligns with the following Western Australian Local Government Areas (LGAs): Shire of Wyndham East Kimberley, Shire of Broome, Shire of Derby-West Kimberley, and the Shire of Halls Creek. The business must have been operating within the Designated Area for at least 12 months prior to seeking endorsement. Exceptions to this 12 month period will be considered on a case by case basis, where exceptional circumstances exist (for example, an established business operation has been taken over by a new entity within the last twelve months, or the business is in a critical sector). The position/s being sought under the Kimberley DAMA must also be based within the Designated Area. REFER ITEMS 1.2 AND 1.3 IN KIMBERLEY DAMA INFORMATION GUIDE.
